Terms & Conditions:

- Interested applicants must apply through the **Online Job Portal** available on the University of Rasul website: <https://jobs.uorm.edu.pk/>. The online application, along with all required documents, must be submitted no later than **26.06.2026** after depositing the prescribed processing fee. Hard copies of the same application and documents must reach the Office of the Registrar by **30.06.2026**. Applications received after the stipulated deadlines, in either form, shall not be entertained. Online applications, once submitted, cannot be edited or modified.
- Applicants must submit a duly signed complete dossier, comprising the printed online application form; attested copies of all educational documents, including degrees and transcripts/DMCs (both sides) duly verified by HEC/Boards; first page of publications/articles (if applicable); experience certificates; duly verified Employment Verification Proforma (EVP); NOC (if applicable); and copies of domicile and CNIC, to be submitted through courier service.
- Candidates applying for the posts of Professor and Associate Professor shall provide three (03) complete sets of the dossier, whereas applicants for all other positions shall submit one (01) complete set only.
- Applicants are advised to carefully read all instructions and ensure that their applications are complete in all respects before submission.
- Submission of both online and hard copy applications is mandatory. Applications missing either component shall be treated as incomplete and rejected.
- Candidates applying for more than one post must submit separate applications for each position.
- Incomplete applications, incorrect information, or concealment of facts shall result in disqualification at any stage.
- Applicants serving in Government, Semi-Government, or Autonomous Bodies must apply through proper channel and attach a valid NOC issued by the Appointing Authority, along with verified experience certificates.

All claimed experience shall only be considered if supported by documentary evidence duly verified as per the prescribed EVP.

10. Experience in private organizations shall be accepted only if the entity is registered with SECP/Registrar of Firms/Competent Regulatory Authority.
11. Experience on daily wages, part-time, visiting, honorary, or apprentice basis shall not be considered.
12. Applicants under the Tenure Track System (TTS) shall be governed by HEC TTS Statutes and relevant policies.
13. Candidates whose results are not officially declared by the closing date shall not be considered.
14. Applicants possessing foreign qualifications must submit HEC/IBCC equivalence certificates.
15. Applicants claiming equivalence of qualifications must provide documentary proof issued by relevant authorities (HEC/PEC/IBCC, etc.), failing which candidature shall be cancelled.
16. Shortlisting shall be carried out in accordance with University procedures. Only shortlisted candidates shall be called for test/interview.
17. The name of the post applied for must be clearly written on the top right corner of the envelope.
18. The University shall not be responsible for delays due to courier or postal services.
19. Quota for minorities, women, and persons with disabilities shall be observed as per Government rules.
