

ADMISSION POLICY FALL 2026, UNIVERSITY OF RASUL

Effective Date

Fall 2026 Admissions

1. Introduction

University of Rasul is committed to providing transparent, merit-based, inclusive, and quality admissions to all undergraduate degree programs in accordance with the guidelines of the Higher Education Commission (HEC), relevant accreditation councils, and university regulations.

This policy establishes the admission framework, eligibility requirements, merit determination criteria, entry test requirements, reserved quota criteria, and admission procedures for all undergraduate programs offered by the University of Rasul.

The policy applies to all undergraduate degree programs offered under the semester system at UOR.

2. Objectives of the Policy

The objectives of this policy are to:

1. Ensure transparency and fairness in admissions.
2. Establish standardized admission criteria across all faculties.
3. Ensure compliance with HEC and accreditation body requirements.
4. Promote merit-based admissions while facilitating access through reserved quotas.
5. Define admission procedures, documentation requirements, and merit calculations.
6. Maintain academic quality and institutional standards.

3. Scope

This policy applies to all undergraduate degree programs (Annexure-A) offered by the following faculties of the University of Rasul:

1. Faculty of Engineering, Computing and Physical Sciences
2. Faculty of Business, Economics and Law
3. Faculty of Social Sciences
4. Faculty of Health and Natural Sciences
5. Any future undergraduate programs approved by the relevant statutory bodies and the University.

This policy does not apply to postgraduate programs unless specifically stated.

4. General Admission Principles

4.1 Admission Cycles

Admissions to undergraduate programs shall normally be offered in Fall and/or Spring semesters, subject to:

- Availability of seats
- Faculty resources
- Accreditation requirements
- Approval by competent authorities

4.2 Medium of Instruction

The medium of instruction and evaluation at UOR shall be English unless otherwise approved.

4.3 Co-Education

University of Rasul shall remain a co-education institution for undergraduate degree programs.

4.4 Merit-Based Admissions

Admissions shall be granted strictly on merit, subject to:

- Eligibility criteria
- Reserved quota policies

- Accreditation requirements
- Availability of seats

4.5 Seat Allocation

The University reserves the right to:

- Determine the number of seats in each program
- Increase or decrease intake capacity
- Suspend or not offer any program due to insufficient enrollment or accreditation constraints

4.6 Compliance with Regulatory Bodies

All admissions shall comply with:

- Higher Education Commission (HEC)
- Pakistan Engineering Council (PEC)
- Pharmacy Council of Pakistan (PCP)
- Pakistan Bar Council (PBC)
- National Computing Education Accreditation Council (NCEAC)
- National Technology Council (NTC)
- Relevant accreditation councils and regulatory authorities

5. General Eligibility Requirements

5.1 Basic Eligibility

Applicants seeking admission to undergraduate programs must have:

- Passed Intermediate/HSSC or equivalent qualification recognized by the Board Committee of Chairmen (IBCC); OR
- Passed relevant Diploma of Associate Engineering (DAE) recognized by the Punjab Board of Technical Education (PBTE); OR
- Passed an equivalent foreign qualification recognized by IBCC.

5.2 First-Year Result-Based Applications

Applicants may apply on the basis of:

- First Year Intermediate results, or equivalent qualification

However, admission shall remain provisional until submission of the final consolidated result meeting the prescribed eligibility criteria.

5.3 Minimum Eligibility Requirement

The minimum eligibility percentage shall vary by program and faculty as prescribed in this policy.

5.4 Foreign Qualifications

Applicants possessing foreign qualifications shall submit:

1. IBCC Equivalence Certificate
2. Official transcript
3. Officially translated documents if required

5.5 Official Translation Requirement

If educational documents are in a language other than English or Urdu, officially translated copies verified by the relevant authority shall be mandatory.

5.6 Age Limit

Undergraduate Degree Programs

- Maximum age limit: 25 years
- Relaxation up to 30 years may be granted to:
 - Female candidates
 - Special persons
 - Applicants with valid reasons

- Subject to accreditation body restrictions

5.7 Admission Cancellation

Admission shall be cancelled if:

- False information is provided
- Forged documents are submitted
- Minimum eligibility is not met in the final result
- Required documents are not submitted within the prescribed timelines
- Admission dues are not deposited within the stipulated time

Eligibility

Applicants must have at least 50% marks (BS Computer Science, IT, AI and SE) while atleast 45 % marks (for BS Physics, Mathematics and Statistics) in:

- Intermediate (Pre-Medical, Pre-Engineering, ICS, or Science Group); OR
- Equivalent qualification
- Applicants must have studied:
- Mathematics (150 marks); and
- Computer Science (100 marks), where applicable.

Additional Requirement for Pre-Medical Students

Applicants from the Pre-Medical or Science Group without Mathematics shall complete deficiency courses in Mathematics within one year of regular studies.

Merit Determination

Merit shall be determined on the basis of:

- First Year Intermediate marks; OR Equivalent qualification
- Admission shall stand cancelled if the applicant fails to secure at least percentage marks (50% or 45%, as the case may be) in the final consolidated result.

Eligibility

Applicants must have at least 50% marks in:

- Intermediate (Pre-Engineering, Pre-Medical, ICS); OR
- Equivalent qualification

Entry Test Requirement

Applicants must submit one of the following:

- Valid UET Engineering College Admission Test (E-CAT)
- Valid SAT
- UOR Departmental Entry Test

Merit Calculation

Merit shall be calculated as follows:

- 70% Intermediate (First Year)/DAE (First Two Years)
- 30% Entry Test (E-CAT/SAT/UOR Entry Test)

Additional Requirement for Pre-Medical Students

Pre-Medical students without Mathematics shall complete Mathematics deficiency courses within one year.

NOTE:

- At least 50% marks are required in the intermediate (Pre-Medical, Pre-Engineering, Computer Science (ICS) or equivalent) or relevant three-year Diploma duly recognized by the Punjab Board of Technical Education (PBTE) to stand eligible for admission. Otherwise, the admission shall be cancelled.
- E-CAT (conducted by the UET Lahore) or SAT or University of Rasul Departmental Entry Test Score is mandatory for the calculation of merit (i.e. 70% academic+30% entry test).
- The applicants having a DAE may apply against open merit. No reserve quota is allocated.
- The Applicants with Pre-Medical or Science Group without Mathematics shall cover the deficiency of two courses in Mathematics within one year of their regular studies.

Eligibility

For BBA (4 Year) Applicants must have at least 50% marks in:

- Intermediate or equivalent qualification

For BS Commerce, BS Economics, BS Hospitality Management, BS Public Policy and Governance

Applicants must have at least 45% marks in:

- Intermediate or equivalent qualification

Merit Determination

Merit shall be determined on the basis of:

- First Year Intermediate marks, or equivalent qualification

Admission shall remain provisional until the final consolidated result meets the required percentage.

6.2.1 LLB

Eligibility

Applicants must have:

- Minimum 45% marks in Intermediate or equivalent qualification
- Valid HEC Law Admission Test (LAT) with minimum passing score prescribed by HEC/PBC

Merit Determination

Merit shall be determined on the basis of:

- Intermediate (First Year) marks; OR equivalent qualification
- Valid LAT score
- Additional criteria approved by the Faculty/University

Additional Requirements

Admissions to LLB shall comply with:

- Pakistan Bar Council Rules
- HEC policies

- University regulations

Programs

1. B.Ed. (Hons.)
2. B.Ed. (1.5 Years)
3. BS English (Language & Literature)
4. BS International Relations
5. BS Political Science
6. BS Psychology

Eligibility

Applicants must have at least 45% marks in:

- Intermediate or equivalent qualification; OR equivalent qualification

Merit Determination

Merit shall be determined on the basis of:

- First Year Intermediate marks, or equivalent qualification
- Admission shall be confirmed upon submission of the final consolidated result meeting the minimum eligibility.

6.4 Faculty of Health and Natural Sciences

6.4.1 BS Biotechnology

6.4.4 BS Microbiology

Eligibility

Applicants must have at least 45% marks in:

- Intermediate (Pre-Medical or Science Group with Biology); OR Equivalent qualification

Merit Determination

Merit shall be determined on the basis of First Year Intermediate marks.

6.4.5 BS Chemistry

Eligibility

Applicants must have at least 45% marks in:

- Intermediate (Pre-Medical, Pre-Engineering, or Science Group with Chemistry); OR equivalent qualification

Merit Determination

Merit shall be determined on the basis of:

- First Year Intermediate marks

6.4.6 BS Environmental Sciences

Eligibility

Applicants must have at least 45% marks in:

- Intermediate (Pre-Medical, Pre-Engineering, ICS, or Science Group with relevant subject); OR equivalent qualification

Merit Determination

Merit shall be determined on the basis of:

- First Year Intermediate marks

6.4.7 BS Medical Lab Technology

Minimum 50% marks in F.Sc pre-medical/ equivalent are required

Merit Determination

Merit shall be determined on the basis of First Year Intermediate marks.

6.4.8 Pharm-D

Eligibility

Applicants must have at least 60% marks in:

- HSSC Pre-Medical; OR Equivalent qualification

Merit Determination

Merit shall be determined on the basis of First Year Intermediate marks.

Admission shall stand cancelled if the applicant fails to secure at least 60% marks in the final consolidated result.

Additional Requirements

Admissions to Pharm-D shall comply with:

- Pharmacy Council of Pakistan regulations
- HEC policies
- University rules

7. Entry Test Policy

7.1 University Admission Test

University of Rasul may conduct:

- University Admission Test
- Departmental Entry Tests
- Interviews
- Aptitude assessments

where required.

The University shall notify minimum passing scores in entry tests in accordance with accreditation and regulatory requirements.

8.1 Tie-Breaking Criteria

In case of equal merit:

1. Higher marks in relevant subjects
2. Higher overall Intermediate marks
3. Earlier application submission date
4. Decision of the Admission Committee

shall apply sequentially.

9. Reserved Seats and Quotas

9.1 General Principles

Reserved quota applicants must:

- Fulfill minimum eligibility criteria
- Submit the required supporting documents
- Apply within prescribed timelines

Unfilled reserved seats may be converted to open merit seats.

9.2 Categories of Reserved Seats

1. Special Persons (Annexure-B)

- 2% seats reserved
- Disability certificate required
- Medical Board assessment may be conducted.

2. Sports Persons

- 2% seats reserved
- Sports certificates and trials required

3. Ex-FATA

- 2% seats reserved
- Domicile and CNIC required

4. Balochistan

- 1% seats reserved
- Government nomination required

5. Gilgit-Baltistan

- 1% seats reserved
- Government nomination required

6. Azad Jammu and Kashmir (AJK)

- 1% seats reserved
- Government nomination required

7. Wards of Shuhada / Armed Forces Personnel

- 1% seats reserved
- A relevant armed forces certificate is required

8. Minorities

- 2% seats reserved
- NADRA documentation required

9. Children of UOR Employees

- 5% seats reserved
- Employment certificate and NADRA documentation required

10. Children of Overseas Pakistanis

- 5% seats reserved
- Foreign education documents and equivalence are required

10. Admission Procedure

10.1 Online Application

Applicants shall apply online through the official UOR admission portal.

10.2 Application Requirements

Applicants shall upload:

- CNIC/B-Form
- Educational documents
- Photographs
- Relevant certificates
- Equivalence certificates, where applicable

10.2.1 Required Documents

Applicants shall submit:

1. CNIC/B-Form
2. Matric certificate/result card
3. Intermediate result card/certificate
4. DAE transcript (where applicable)
5. Equivalence certificate (where applicable)
6. Passport-size photographs
7. Domicile (if required)
8. Reserved quota documents (if applicable)
9. LAT/E-CAT/SAT score card (where applicable)
10. Any additional documents required by the University

10.3 Multiple Applications

Applicants may apply to more than one program, subject to eligibility.

10.4 Merit Lists

Merit lists shall be displayed:

- On departmental notice boards
- On the official admission portal

10.5 Admission Confirmation

Selected candidates must:

- Appear before the Admission Committee
- Present original documents
- Submit attested copies
- Deposit admission dues within the stipulated time

10.6 Failure to Deposit Fee

Failure to deposit dues within the prescribed timelines shall result in automatic cancellation of admission.

10.7 Admission, Tuition and Other Charges (Annexure-C)

All selected candidates shall be required to deposit the prescribed admission dues, tuition fee and other applicable charges within the timelines notified by the University. Failure to deposit the prescribed dues within the stipulated period shall result in cancellation of admission, and the seat may be offered to the next eligible candidate on merit.

10.7.1 One-Time Charges (Payable at the Time of Admission)

The following one-time charges shall be payable by all newly admitted students at the time of admission:

Refundable Security Deposit	5,000/-
Total One-Time Charges	11,500/-

10.7.2 Recurring Semester Charges

The following charges shall be payable by all students in each semester throughout the duration of the degree program:

Description	Amount (Rs.)
Tuition Fee	15,000/-
Semester Dues	22,000/-
Total Semester Charges	37,000/-

10.7.3 Hostel Charges

Students availing hostel accommodation shall be required to pay hostel charges, mess charges and other related dues as notified by the University from time to time. Hostel accommodation shall be provided subject to availability and compliance with University rules and regulations.

10.7.4 Transport Charges

Students availing University transport facilities shall be required to pay transport charges as prescribed and notified by the University from time to time. The transport facility shall be provided subject to the availability of routes, operational feasibility and compliance with relevant regulations.

10.7.5 Refundable Security Deposit

The refundable security deposit of Rs. 5,000/- shall be refunded upon completion of the degree program or withdrawal from the University, subject to clearance of all outstanding dues, return of University property and fulfillment of prescribed formalities.

10.7.6 Revision of Fees and Other Charges

The University reserves the right to revise admission charges, tuition fees, semester dues, hostel charges, transport charges and any other fee or charges from time to time with the approval of the competent authority. Any revision shall be notified separately and shall become effective from the date specified in the relevant notification.

11. Hostel Facility

Hostel accommodation may be provided subject to:

- Availability
- University policy
- Priority criteria

Preference may be given to students from outside District Mandi Bahauddin.

12. Admission Grievance Redressal

Applicants may file admission grievances within two working days of the merit list display.

The grievance shall be submitted to the relevant Faculty Dean along with supporting documents.

The decision of the University shall be final.

13. Admission Committees

13.1 University Admission Committee

The University shall constitute a central admission committee to:

- Supervise the admission process
- Ensure policy compliance
- Approve admission decisions

13.2 Departmental Admission Committees

Each department shall constitute an admission committee responsible for:

- Verification of documents
- Merit preparation
- Interviews if applicable
- Admission recommendations

14. Fraud and Misrepresentation

Any candidate found involved in:

- Forgery
- Misrepresentation
- Concealment of facts
- Submission of fake documents

shall face:

- Immediate cancellation of admission
- Disciplinary action
- Legal proceedings where applicable

15. Special Cases

The University may consider special cases not covered in this policy through:

- Academic Council
- Vice Chancellor approval
- Admission Committee recommendations

subject to HEC and accreditation body regulations.

16. Policy Review and Amendments

This policy may be reviewed periodically by the University.

Any amendments shall require approval from competent statutory authorities.

The University reserves the right to revise:

- Eligibility criteria
- Seat allocation
- Merit calculation
- Entry test requirements
- Admission schedules

In accordance with HEC and accreditation body directives.

17. Interpretation of Policy

In case of ambiguity in the interpretation of any clause of this policy:

- The interpretation of the University shall prevail.
- The decision of the Vice Chancellor shall be final.

18. Effective Implementation

This policy shall come into effect upon approval by the competent authority and shall apply to all undergraduate admissions thereafter.

Annexure –B

Policy for Students with Disabilities at Higher Education Institutions

The Higher Education Commission policy “Policy for Students with Disabilities at Higher Education Institutions in Pakistan (2021 Amended)”, will be adopted for the University of Rasul admission policy:

1. Equal Opportunity and Non-Discrimination

- No applicant shall be denied admission on the basis of disability.
- Students with disabilities shall be provided equal opportunity to access higher education and participate in academic and extracurricular activities.

2. Disability Disclosure in Admission Forms

- Admission forms shall include a dedicated section for applicants to disclose disabilities voluntarily.
- Applicants may provide:
 - Disability Certificate,
 - CNIC with disability logo,
 - NADRA registration proof as a special person.
- Disclosure of disability shall not negatively affect the admission decision.

3. Accessible Admission Information

- The university website, prospectus, advertisements, and admission forms shall be accessible for persons with disabilities.
- Contact details of Disability Coordinators shall be clearly displayed in all admission materials.

4. Disability Support and Consultation

- Applicants with disabilities shall be consulted regarding their accommodation needs during admission and entrance testing.
- The university shall guide available facilities and support services.

5. Entrance Test Accommodations

Students with disabilities shall be entitled to reasonable accommodations during entry tests/interviews.

6. Alternative Assessment Arrangements

- Where necessary, applicants may be exempted from a part of the entrance examination due to disability.

- Alternative assessment methods may be used with the approval of the Academic Council.

7. Financial Assistance and Fee Waiver

- The university shall provide need-based financial assistance to students with disabilities.
- Tuition fee, hostel fee, and utility charges may be waived for eligible needy students with disabilities.
- Available concessions and waivers shall be clearly mentioned in the prospectus and website.

8. Age Relaxation

- Students with disabilities may receive age relaxation up to ten years for admission to educational programs.

9. Accessibility Committee and Disability Coordinators

- The university shall establish an Accessibility Committee.
- Disability Coordinators shall assist applicants and enrolled students regarding admissions, accommodations, and support services.

10. Grievance Redressal Mechanism

- Students with disabilities shall have access to a formal complaint mechanism for discrimination, denial of facilities, or mistreatment.
- Complaints may be submitted to Disability Coordinators, the Accessibility Committee, or the Vice Chancellor's office.

University of Rasul Scholarship Policy 2026

1. Preamble

The University of Rasul (UOR) is committed to promoting inclusive and equitable quality education and promoting lifelong learning opportunities for all by supporting students from marginalized, disadvantaged, and underrepresented groups. This policy aims to establish a sustainable, institutionally funded scholarship system that ensures continuity and fairness independent of external fluctuations.

The University strongly believes that providing financial support is an institutional responsibility and a fundamental part of our mission of nation-building. Education transforms individuals and communities, and universities must "give back" by providing meaningful opportunities to students unable to finance higher education.

The Equity, Diversity & Inclusion (EDI) represents a commitment to fair treatment and equal access for students from diverse socioeconomic, cultural, gender, disability, or minority backgrounds. A diverse student body enriches academic life, encourages social awareness, and promotes values of inclusivity, respect, and unity.

This policy defines the objectives, categories, eligibility criteria, application processes, terms and conditions, and governance structures for all internally and externally funded scholarships.

2. Objectives

The objectives of this Scholarship Policy are to:

- i. Promote access to higher education for students from marginalized or underrepresented communities.
- ii. Support academically outstanding students through merit-based scholarships.
- iii. Encourage diversity by supporting minority groups, differently-abled students, transgender students, single parents, and students from remote or underserved regions.
- iv. Provide financial relief to students facing socioeconomic hardship.
- v. Create a transparent, accountable, and sustainable system for scholarship allocation and monitoring.
- vi. Strengthen University-community relations through educational equity and social responsibility.
- vii. Align institutional goals with national priorities by empowering students through financial support.

3. Scholarship categories

UOR classifies scholarships into the following major categories:

- A. Merit Scholarships
- B. Equity, Diversity & Inclusion (EDI) Scholarships
- C. Vice Chancellor's Special & Discretionary Scholarships
- D. External Scholarships

A. Merit scholarships

Scholarships will be awarded based on academic excellence, competitive merit, and high achievements.

A1. UOR Merit Scholarship

Merit scholarships for new admissions will be awarded on the following criteria:

Scholarship Category	Criteria	Scholarship Awarded
Category 1	90% or Above marks	100% fee waiver, including transport/hostel
Category 2	85%-89.99% marks	75% Tuition fee waiver
Category 3	80%-85% marks	50% Tuition fee waiver

A2. Subsequent Semester Merit Scholarship

Students who were not awarded a merit scholarship at the time of admission may become eligible for a Subsequent Semester Merit Scholarship based on their academic performance at UOR, according to the following criteria:

Criteria	Scholarship Award
3.50 and above	100% Tuition Fee Waiver

The Subsequent Semester Merit Scholarship will be announced annually. Eligible students may apply when applications are invited by the University.

A3. Overseas & AJK Merit Scholarship

Top 20 overseas (having nationality other than Pakistan)/AJK applicants with a minimum 75% admission merit.

Coverage: Full Tuition Fee.

A4. UOR Merit Scholarship (Departmental Positions)

The UOR Merit Scholarship (Departmental Positions) shall be awarded on the basis of semester GPA and academic standing within each academic program. To be eligible, a student must secure a Semester GPA of **3.50 or above**. Merit Scholarships shall be awarded to the top-performing students in each program based on their semester results. No scholarship shall be awarded in a program where the highest Semester GPA is below 3.50.

First Position: Rs. 20,000/-

A7. Dean's Merit Scholarship

One top student per faculty each academic year.

Award: Rs. 50,000 (one-time)

B. EDI Scholarships

Supporting marginalized, financially disadvantaged, or underrepresented groups.

B1. Scholarships for Orphans/Divorced Mothers

Coverage: 100% fee waiver, including transport/hostel.

B2. Need-Based Scholarships

For economically disadvantaged students meeting UOR or HEC criteria.

Coverage: Full Tuition + Stipend. Selection by the Institutional Scholarship Award Committee (ISAC) or the Vice Chancellor.

B3. UOR Tuition Fee Concession (TFC)

50-100% tuition fee concession based on verified family income. Selection by the Institutional Scholarship Award Committee (ISAC) or the Vice Chancellor and subject to the availability of the budget.

B4. Scholarships for Minority Communities

Coverage: Full Tuition Fee after getting admission.

B5. Scholarships for Physically Challenged Students will be awarded as per the HEC Policy for Students with Disabilities 2021

B7. Scholarships for Transgender Students

Applicants with NADRA-recognized transgender status.

Coverage: 100% fee waiver, including transport/hostel after getting admission.

B8. Emergency/Compassionate Grants

For students facing crises (death of a guardian, medical emergency, disaster loss).

Selection by the Institutional Scholarship Award Committee (ISAC) or the Vice Chancellor and coverage is subject to the availability of the budget.

B9. Sports-based Scholarship

Students who aspire to compete at the highest levels within their chosen sport. The university facilitates these students with academic flexibility and financial relief to help them easily attain their goals. The Committee will evaluate the case.

Coverage: 25-100% based on budget and case

B10. Employee Children Fee Waiver

Coverage: Full Tuition Fee for 1st child and 50% Tuition Fee for 2nd child.

C. Vice Chancellor's Special Scholarship

Upto 20 awards per year at the discretion of the Vice Chancellor to students with:
Exceptional academic/extracurricular achievements, Or Critical financial hardship.
Subject to the availability of the budget.

4. Application Process

4.1 Announcement of Scholarships

The Directorate of Financial Aid and Scholarship (DFAS) shall announce scholarships through:

- > University Website
- > Official Email System
- > Department Notice Boards
- > Social Media Platforms (optional)

4.2 Application Submission

- > Applications must be submitted at admission or during designated call periods.
- > Need-based scholarships may be announced each fall semester.
- > All applications must include required supporting documents.

4.3 Review & Shortlisting

- > DFAS shall verify eligibility and completeness of applications.

Shortlisted candidates will be interviewed by the Institutional Scholarship Award Committee (ISAC).

4.4 Approval

- > Final decisions by ISAC, endorsed by Competent Authority.

5. Terms and Conditions

5.1 Minimum CGPA Requirement

► Merit Scholarship A1.

Students shall avail themselves of the merit-based scholarship for the first two semesters of their program. They will be assessed to retain the scholarship based on the following CGPA criteria after completing the second semester. However, the student admitted on various Categories in Fall 2025 shall have to maintain the following CGPA requirements from Spring 2027.

► Merit Scholarship A2.

► Recipients of all other categories will: Maintain a CGPA of 2.7 per semester.

> Physically challenged students: CGPA requirement not applied.

> Sport-based scholarship will require a CGPA of 2.00 or higher for continuation

5.2 Academic Load

Student must be enrolled full-time, taking a complete semester credit hrs load.

5.3 Program Interruption

Students exceeding standard duration or taking extra semesters are ineligible.

Semester freeze is allowed without penalty.

5.4 Completion Time

The scholarship will be applicable only for the standard duration of the degree program.

5.5 Failure to Complete Program

The university may recover the full scholarship amount + penalty equal to the disbursed amount.

5.6 Dual Scholarships

Students can hold only one internal UOR scholarship.

Merit-based (semester/annual) awards are exempt.

External scholarship rules override internal rules if the donor specifies.

5.7 Hostel Meal Exclusion

Scholarships providing hostel accommodation do not include meal charges.

6. Termination of Scholarship

The scholarship may be terminated if the student does not comply with the rules, regulations, and conditions applicable to the awarded scholarship category.
